Crawford requested authorization for the roof contractor to repair the roof on the municipal building at the SRPD portion where the rain blows under the shingles. Motion by E. Paules, seconded by K. Earll to authorize Top Quality Construction to repair the roof NTE \$ 1000. Motion carried.
